It was discussed that the two former elementary schools (JFK & South) have been offered through the Request for Proposals (RFP) process, but the proposals were not accepted. Mr. Gordon recommended hiring a marketing firm to handle the process in the fall to look for a project that would benefit the Town.

Communications Director Hooke explained that he is requesting that the Board approve adding the position of Deputy Director of Communications to the list of Town positions approved to receive CELL PHONE REIMBURSEMENT. This position is 24/7 for six towns, is responsive to the other towns' issues, and is paid out of a budget which is funded by fees from the other towns.

Director Hooke said that with Rockland coming onboard, three new part-time PUBLIC SAFETY TELECOMMUNICATORS and a full-time person need to be hired. He asked that the Board approve the hiring of the three people he is recommending this evening. They will go through 911 training, Holbrook training, and State mandated training before coming on board.

The new INFORMATION TECHNOLOGY (IT) position that was approved at town meeting in May is also ready to be filled. Director Hooke recommended a gentleman who works in a neighboring town and is familiar with the Town's equipment.

Discussion took place about the location of future TOWN ELECTIONS. The School Department has notified the Town Clerk that the elections cannot be held in the new school building.

Supt. Hamilton explained that there are safety concerns with having the elections in the school, and the elections were not anticipated when the school calendar was set. School could be cancelled for the September 4th election, but the school calendar cannot be changed for the other elections, which would require closing the school for the day. The Town Clerk said the building is not conducive to elections, there is not enough parking, and the walk is too long for the elderly and disabled. Ms. Tarara has spoken with Fr. Boudreau, and St. Joseph School is willing to work with the Town on holding elections at their school. Fr. Boudreau said he has contacted the Archdiocese, and the School could block off the auditorium and accommodate elections, beginning in November. No vote was taken. Moving the elections will be discussed and voted at a meeting in September.

Treasurer/Collector Digirolamo recommended that the Board vote to renew the agreement with Mr. David Leary for professional services related to CASH RECONCILIATIONS. He indicated that filling the HR position would free up some of the Assistant Treasurer's time to take over the reconciliations.

Chief Smith announced that the Department had an assessment done on July 11th & 12th, and the Department is now Certified. There will be a formal ceremony in September. The Chief also reported that grants have been received for \$2,500 of equipment through Mass. Emergency Management, a new K9 and a new speed sign.

Mr. Reilly asked that when the department heads communicate important matters to staff at the Town Hall, that they also send the email to the members of the Board of Selectmen.

Mr. Lee presented Board members with a job description for the position of Director of Inspectional Services, and explained that there would be one person who would be accountable for the department. Ms. Vayda asked that this job description also require that this person have knowledge about marijuana facilities. Mr. David Reilly suggested that the director have a construction supervisor's license and be able to read blue prints.

Discussion took place with residents of the Spring Street area, including Ms. Carmella Silva and Ms. Robin MacCallum, and Ms. Lisa DeMarco-Topping of Avon, about the ongoing issues related to work taking place at 55 HIGH STREET, where asbestos has been identified. The neighbors want the building sealed. The project is being overseen by the Department of Environmental Protection at this time. Board of Health member Katie Goldrick reported that she called the DEP and was told that there is a work plan in place. Chairman Campanella explained that she and others have been working on this issue, and the permits will be available online. What is allowed and not allowed will be shared.

Discussion took place with Ms. Diana DiMartino about the issue of the 17 dogs being kept at 429 SOUTH STREET, and the clearing of the parcel of land at 4 Indian Road. Chairman Campanella forwarded information to the Building Inspector and a cease and desist has been issued related to excavating. The neighbors reported that violations are taking place on weekends. There is a limitation of 3 dogs, and there is no kennel license issued. Chief Smith said the Police Department will go there

and serve her. The resident of 37 Dale Road said he works odd hours, and the dogs are interfering with his sleep.

Supt. Pellitteri notified the Board about a drainage issue on Revere Street. He reported that the drain goes under a resident's home, and the estimated cost for repairs is \$200,000. All of the drains in Revere Acres will be looked at. The Richard Road water project will begin in about 6 weeks. It was discussed that the MS4 storm water permit process is out 2 – 3 years, and is very costly. This year's cost is estimated at about \$11,000. The cost will be incremental, but the town will need to figure out how to pay for it. Mr. Lee commented that solid drainage plans of the town are necessary and suggested that the Norfolk County Commissioners be contacted about the funding.

Director Hooke announced that Communications Supervisor Anthony Fowler was one of five recipients of a Communications Management Scholarship in the amount of \$10,000 for leadership training.

Chiefs McFadden and Smith, and Director Hooke all reported that their departments assisted the Town of Weymouth by helping during the funeral, attending the wake/funeral, or supporting Weymouth by sending dispatchers to help the town following the tragic death of Weymouth Sgt. Michael Chesna.
