The meeting was called to order at 7:00 p.m. by Chairman Campanella in the Selectman Noel C. King Meeting Room, Holbrook Town Hall, Floor 3R, 50 North Franklin Street, Holbrook, MA 02343, and began with the Pledge of Allegiance.

o The Board of Health is accepting resumes for the position of full-time Health Agent

S. Sgt. Jason T. Pickard, from the U.S. Army Recruiting Station in Quincy, explained that he is from a small town in South Carolina and would like to be part of the Holbrook community through volunteering. He introduced his Commanding Officer, Captain Alexander.

Atty. Phil Silverman, representing MASSMEDICUM CORP. explained that the medical cultivation of marijuana at 1 Mear Road is just about active. They would now like to discuss the adult use side, including cultivation and manufacturing, with no dispensary. They are willing to waive their rights to dispensaries. Payments would be made to mitigate the impact, which is less with cultivation and averages 1-1.75% of gross revenue. Mr. Silverman explained the options available to the Board for agreements, and different options were discussed. The majority of the Board was in favor of keeping the first agreement in place and going with a separate 5 year agreement for cultivating adult use

marijuana, with a 3% cap and no sales. Ms. Vayda explained that the Town should wait until the medical gets off the ground and knowledge about the impact is better understood.

Mr. Silverman explained that the payments made should reflect the impact of the facility on the community. The payments could be reviewed from time to time to make sure they are reasonably related to the costs the Town incurs.

Ms. Pamela Vayda of Holbrook Cares asked about the Town having a moratorium on marijuana, and was advised that the Town does not have a moratorium in place.

Mr. Eryc Cormac commented that Holbrook voted in favor of recreational marijuana in the state, and cited people he knows who have benefitted medically by the use of marijuana.

Atty. Silverman explained the process that will be used for the delivery vehicles leaving the facility to go to retail facilities. They will be unmarked vehicles with GPS tracking, 2 people, no stops, 2 way communication. The water used will be filtered through reverse osmosis.

Discussion: It was discussed that termination language needs to be added, so that if there is a

violation of the local or state regulations or laws, the agreement could be terminated.

Mr. Tom Benvie, a member of the Historical Society, spoke to the Board about various subjects:

- The war monuments in Mary Wales Holbrook Park include the medallion for each war, except Vietnam. A plan has been made to have the medallion in place by Veterans' Day of this year.
- o This upcoming Veterans' Day, the 100th anniversary of World War I will be celebrated. Mr. Benvie would like to have people sponsor a flag in order to create a field of flags on Mary Wales Holbrook Park, and hold a Veterans' Day ceremony on November 10th or 11th.
- He would like to add a Vietnam Honor Roll to the ones the Town already has for previous wars.
 Anyone to be listed on the Honor Roll will need to have enlisted while they lived in Holbrook, making Holbrook their "town of record".
- He would like the Boston Post Cane tradition to be resumed in Holbrook. A replica, which would be displayed in Town Hall, would honor the oldest resident of Holbrook who has been in Town for a minimum of 10 years.
- o Mr. Benvie explained that the Holbrook Hall of Fame, formerly housed at Holbrook High, needs to be continued, and he would like to have a ceremony held to induct a list of people he has compiled. He suggested that the area of the Town Hall located outside the Town Clerk's office, could be used for a wall of honor and display cases.

Mr. Gordon explained that at the 2017 fall town meeting, money was appropriated under Article 20 for the owners' project manager for the Tri Town Water Treatment Plant Project. That contract is before the Board for approval.

MOTION: By Mr. Lee, second by Mr. Reilly, that the Board of Selectmen execute a contract

between the Tri-Town Water Board and Environmental Partners Group, Inc. for Water Treatment Plant Owners' Project Manager (OPM) Services, with Holbrook's 16% share

of the total contract cost to be \$50,858.08

Mr. Gordon explained that the Union Street Roadway Improvement Project has been placed on the state's Transportation Improvement Plan (TIP) for 2021. The engineering needs to be finalized. The project goes from Pleasant Street to the culvert before the Cochato. The sidewalks are included. It is a \$2.5 million project.

Mr. Lee asked about the project on Pond Street. Supt. Pellitteri said that Pond Street is a larger project, requiring more Chapter 90 money, so smaller projects are being completed at this time.

execute Amendment No. 1 to the Agreement for Professional Services between The Town of Holbrook and BETA Group, Inc. for the Union Street Roadway Improvements

Director Hooke requested that the Board support the hiring of four new Telecommunicators to fill vacancies. He explained that there will still be one full-time opening, and any new per diem employees will be sent to the 911 academy.

Director Hooke said he recently attended a national conference, and was presented with an award for the Communications Center's affiliation with the National Center for Missing and Exploited Children, and that he expects to hear about the 911 FY19 grant about mid-September.

The Animal Control Officer received another generous donation from the Copeland Family Foundation, Inc. of Milton, which must be accepted by the Board.

Mr. Gordon discussed establishing a search committee for the Human Resource Director's position. The job has been advertised, and resumes have been received. Mr. Gordon expects that this position will handle recruiting, bringing finalists to the Board of Selectmen, benefits, grievances, collective bargaining, and retirees, but will not do payroll. Both the Town and the School Department have a need, and the funding is in the budget. Mr. Gordon asked that one member of the Board of Selectmen serve on this committee, and Selectman Vayda indicated she would.

Supt. Pellitteri reported that all items purchased through Capital Improvements this year have been received, including a new asphalt loader. The department is working on the crosswalks. He explained that there is an individual in the PWD who will be out through the month of September, and the employees would like to create a sick bank to donate time to him. Discussion took place about the parameters of doing this now and going forward, including only allowing a bank to be established based on the severity of a disease, and allowing people to donate days, but only charging those who donate based on the percentage their donation represents of the time actually used.
