The meeting was called to order at 7:00 p.m. by Chairman Campanella in the Selectman Noel C. King Meeting Room, Holbrook Town Hall, Floor 3R, 50 North Franklin Street, Holbrook, MA 02343, and began with the Pledge of Allegiance.

Mr. Gordon reported that:

- o The November 6, 2018 State election will be held in the gymnasium at St. Joseph School
- o Early voting hours begin at the Town Hall on October 22, 2018
- o The Annual Fall Lantern Walk in the Town Forest will be held on Friday, October 26, 2018
- o The Request for Proposals (RFP) for the sale of the former South School is prepared in draft. Projects that would be highly advantageous to the Town, advantageous, and not advantageous have been described in the RFP. A project that does not provide significant tax revenue to the Town is also one that would not be considered advantageous.
- He spoke to a firm that markets properties, but it would not be cost effective to hire such a company to market the former South School because the fee was estimated at \$25,000 to \$30,000, whether the property sells or not.
- A town meeting vote is necessary to sell the school property, and it might need to be rezoned, so a town meeting may be necessary in January or February 2019.
- A use of facilities form has been filed with the School Department for the use of the school during 2019 and 2020 for elections. The School Department will accommodate future elections.

- o An analysis of the water/sewer rates was given to the Board.
- Mr. Gordon reported that the 5-member HR Director Search Committee screened 20 applications, and interviewed 6. He said they would like to bring the finalist to the Board.
 Board members indicated that the Board wants to interview the top three candidates at the next meeting.
- o The Board of Health will be hiring the Public Health Nurse and the Health Agent tomorrow.

Mr. Tom Benvie was present to update the Board on the VETERANS' DAY activities he is working on. There will be a ceremony in Mary Wales Holbrook Park on November 11th at 11:00 am in memory of the 100th anniversary of the end of WWI and to honor all veterans. The Field of Flags in the Park will begin on November 3rd, and will be left in place until November 18th. Flags can be sponsored for \$10 each, dedicated to a veteran, if desired. He has updated the list of names of the veterans from Holbrook during 1946 until the present. Mr. Benvie has also been working on a Hall of Fame, and the names will be announced shortly.

Mr. Gordon explained that a SALARY ADMINISTRATION HEARING has been scheduled to amend the wage & salary schedule.

- Add the position of PWD Temporary Seasonal Help to Schedule B, with an hourly rate of "MA Minimum Wage"
- Amend the hourly rate for a Library Page from \$11.00 hourly to "MA Minimum Wage"

Chief McFadden introduced Firefighter/Lieutenant Retired Donald Austin, Jr. and Firefighter/EMT Retired Robert Lawrence, who both retired recently. He spoke briefly about their 40 and 42 year careers with the Department. The retirees were presented with Certificates of Recognition from the Board of Selectmen and were congratulated by all those present.

Boy Scout John B. Kearney, of Troop 56, was recognized for receiving his Eagle Scout Award recently. A Citation was prepared and read in his honor, but he was unable to attend the meeting to receive it in person.

Boy Scout Joseph Sullivan, of Troop 56, was present to speak to the Board about his Eagle Project. He presented information about a flag retirement drop-box for tattered American flags that he has planned and will be building soon.

Town Clerk Jeanmarie Tarara explained that it is time to replace the current voting machines with new computerized machines. The funding to purchase the machines has been approved.

TOWN FOREST COMMITTEE members, Adam Fabian, Chairman, and Heather McLellan, were present to update the Board on upcoming events, including the Lantern Walk on October 26th and a Geocache event on November 4th. The new storage shed is in place at 255 Pine Street. Eagle Scouts have provided a kiosk for a trail and shelves are being built in the shed. Discussion took place about the surveying of the approx. 32 acre parcel abutting the Town Forest and why Norfolk County has not been able to complete the survey. Later in this meeting a firm will be hired to do the surveying. The future of the 32 acre parcel was discussed.

Mr. Paul Cobbett, representing Brookville Bible Church, was present to request the use of the former South School parking lot and gymnasium on November 17, 2018 for a Harvest Festival. He explained that they would need access for one full day, with the function to run from 1:00 pm to 4:00 pm. Set up will take place early in the day, and cleanup will occur after 4:00. They will rent porta pottys. The Church has provided a certificate of insurance to the Town.

Mr. Reilly acted as the Chairman during the discussion on the WPA Form 4A on an Abbreviated Notice of Resource Area Delineation (ANRAD) on an application being submitted to the Conservation Commission for TLA Holbrook's transfer station project at 3 & 6 Phillips Road. The Town owns the parcel at 3 Phillips Road. Attorney Marc Goldstein, counsel for TLA-Holbrook LLC, was introduced. Mr. Lee explained that signing this form will allow it to move on to the Conservation Commission for consideration.

Phillips Road, being submitted to the Conservation Commission by Green Seal Environmental, Inc. on behalf of TLA Holbrook, LLC, and as amended by Attorney

Marc Goldstein

Mr. Gordon presented a Proposal for Professional Land Surveying of the land located at 320R Weymouth Street, for the Board's approval.

of Hoyt Land Surveying, and authorize the Town Administrator to execute the Proposal for Professional Land Surveying Services of the parcel shown on Assessors' Map 5, Lot 2, including approximately 32 acres of land located at 320R Weymouth Street, at a fee

not to exceed \$7,575.00

Mr. Gordon discussed the services provided by a consultant, David Leary, related to cash reconciliation. Mr. Leary's contract expires in November. It was discussed that staff has been trained now, and the work will now be handled by an employee. The Board took no action, allowing the contract to expire.

Department updates:

Chief McFadden reported that the recent Open House at the station was well attended. He is involved in hiring firefighters through civil service. The ladder truck is out of service at this time.

Chief Smith said he has received a Mass. Emergency Management Agency (MEMA) grant, with \$5,000 to be applied to enforcement and \$5,000 to be applied to equipment. The Department's Certification ceremony will be held in Dover on October 24th. The speed limit tracking trailers (2) have been damaged by residents in the neighborhoods where they were being used in order to gather data on speeding on those streets.

Selectman Vayda asked, on behalf of some of the students in the school system if a female officer could come to the school, and if, when officers come do to the school, if they could come 5 minutes earlier. Director Hooke reported that a 911 Department grant has been received in the amount of \$1,939,309.00 for Phase 1 of the construction of the new communications building, with no matching funds from the Town. \$1.1 million was received last year.

Selectman Lee said that Permit Pro, the new permitting software in the Inspectional Services and Assessors Departments is about to go online and nearly ready for permit applications.
