## **Old Business:**

<u>Mandigo Plot Transfer</u> – Deed has been sent to K. Mandigo and the \$10 check for the transfer fee has been forwarded to the Trustee of the Trust Funds for Deposit into the Cemetery Commission account.

<u>Martin's Cemetery</u> – Fields (family name) marker had some extraordinary decorations that go against our cemetery rules. Tina has asked the grounds keepers (Highway or Parks Department) to remove the decorations.

<u>Martin & Heads</u> – the members of the Hooksett Cemetery Commission make periodic visits each month to these two active cemeteries to ensure that they are kept up, reviewed for safety and cleanliness etc. Riverside was recently reviewed by Mike. Nothing remarkable to report.

<u>Bond Family Plot</u> – at Head's Cemetery – Tina to speak with Mabel Bond to discern which plots are available.

<u>Darrah Family Plot</u> at Heads – Mike to forward information to Tina as to where any Darrah's are buried as there may not be a Darrah family plot but Darrah's may be buried under another family name.

<u>American Legion Post</u> request for a veterans' memorial at Head's – Legion member, Tony Burdo, will be contacting Mike to discuss location, size, etc.

<u>Cemetery Commission on Town Web Site</u> is located under the Department of Public Works. The site contains plot and burial fees, trustee's phone number and email and the Cemetery Regulations.

<u>Martin's Fence Post Repair</u> – Mike purchased paint and painted the posts white in the north section.

<u>Head's Sign Repair</u> – Mike to contact Heritage Commission to see if there are any relevant historic factors to the current signage before any repairs or changes are made.

<u>Riverside Cemetery Fence Repair</u> - Mike will obtain three quotes for possible work to be done in calendar year 2010.
