NH History Week

With the agreement of other members, Kathie has booked a "Native American History of NH" program for Monday, Oct 17, to be held at Phoenix Business Computing (formerly Lincoln Park School), 10 Brace Ave, 6:30 p.m. It will run about an hour and a half and will include specific Hooksett and Pinnacle info. The speaker will be cosponsored by the NH Humanities Council. They pay \$200 plus mileage, but we pay an application fee. Sally moved to expend the \$35 fee to NHHC, Roxanne seconded. Unanimously approved.
