Kathie and volunteers put mulch on all the flower beds July 9. Scott moved to expend up to \$50 for mulch, Jim seconded. Unanimously approved.

Discussed planting in the oval. Jim moved to expend up to \$400 for shrubs in the oval, Scott seconded. Unanimously approved. P&R will do the planting.

Volunteers from Knights of Columbus will be painting the Jacob Square sign pole and attaching the redone sign to the flag pole. Scott moved to expend \$30 for paint and materials. Jim seconded. Unanimously approved.

The Kiwanis freed up their \$300 donation for us to use as needed.

Jim moved to spend \$825 for refinishing of the smaller plaques. Scott seconded. Unanimously approved. Kathie will contact the company.
