Kathie found a sponsor (Arnold A. Green, Selectman 1968-1971) and has started getting items for the silent auction. She has gotten 4 volunteers to help with registration and food table; Jim has volunteers to help with the game part.

Members voted unanimously to sell merchandise for benefit of Town Hall Preservation Committee as we have the infrastructure set up. Kathie suggested a travel mug and Cat's Meow cutouts of old town hall, Mt. St. Mary's (have to get permission of the owner), and possibly the old bridge.

Jim made a motion to purchase 100 imprinted travel mugs up to \$360. Kathie seconded. Kathie will proceed with ordering.

Jim made a motion to purchase three Cat's Meow cutouts, the first being the old town hall, for a total up to \$650; Kathie seconded. Kathie will proceed with ordering.
