Kitchen

Open wiring in wall where former microwave was should be covered

Hallway

Low voltage clock wires were exposed – needs cover Recycle bin should be moved away from exit in hallway.

Temporary storage room -

Large amount of combustibles - out of fire code

GMILCS room

Emergency #'s should be posted on phone

Furnace Room-

All wall and ceiling penetrations should be sealed. Need outlet and switch covers Threshold is loose.

Electrical Room

Storage in front of panels should be moved
Penetration holes should be sealed
Electrical panels blocked
Switch covers should be installed
Move ladder and secure it
Move oil base paint or put into fireproof cabinet
Electrical outlets should be GFI protected

Holes should be sealed

Cleaning storage

Missing ceiling tiles
MSDS sheets needed

Large storage -

Switch covers needed
Back door – hard to open
Missing ceiling tiles
Notify alarm company – smoke detector too close to vent – needs to be 3' away
