# Workers' Compensation (WC) Claims/Prevention Trainings

Phil St. Cyr, Primex: Provided brief overview of WC claims to date: explained 5 yrs. of losses, Town having safe equipment & environment for its employees, employees applying safety measures, and training employees on "preventive" measures. WC reports are available on Primex website with permission. Preventive trainings:

- Confined space entry Primex has a Concord, NH on-site simulation.
- <u>Ergonomics</u> 15 min. on-line assessment; if employees believe they need a further assessment they should reach out to their dept. head who in turn can have Primex complete an 30-minute on-site assessment (employee needs to participate in this assessment)
- \*Back Injury Prevention Last training on-site completed by most employees August 2014. On-line training 15 min.
- <u>\*Slip, Trip and Fall Prevention</u> Last training on-site completed by most employees August 2014. On-line training 45 min.

P. St. Cyr: Discussed foot wear traction devices for employees to include Yak Tracks (coiled springs) and Jordan Davids (device you can drive with).
