Dear David:

I understand that you represent the town of Hooksett and, in that capacity, I believe you provide legal counsel to the Hooksett Police Commission. I represent Chief Agrafiotis.

Please pass along my increasing concerns about the conduct of the Commission and, in particular, its member, Mr. Clark Karolian. Mr. Karolian has taken a number of direct and indirect actions towards my client that are creating an increasingly hostile work environment. These actions, I believe, are motivated by Mr. Karolian's angst at my client's willingness to do his job, even under very difficult conditions. Mr. Karolian, *inter alia*, has sought to cut my client's salary, place him on leave, audit him, and micro-manage his department. He has made accusations directly and by innuendo that may harm the Chief's reputation. We are concerned that, knowing the protections of RSA 105:2a, Mr. Karolian seeks to make the Chief's position in Hooksett so unbearable that the Chief feels compelled to resign.

Please consider this fair warning that we consider Mr. Karolian's conduct grossly improper, unprofessional, and a prelude to a constructive discharge—which will implicate RSA 105:2a just as a firing would. In short, whether Mr. Karolian directly fires the Chief, or continues with this cowardly approach, the town is still the body that will suffer.

I suggest cooler heads intercede and urge you to use your good offices to do so.

I have been coming to these commission meetings for over 5 years and it is my opinion that this department has been lacking management for a very long time. It's the commission's right and responsibility to question this management especially for the following reasons:

- This department has problems retaining officers.

- Lost the K-9 program.
