At 6:07 p.m. Captain Daigle went to get the job posting and returned it to Chairperson McHugh at her request.

At 6:13 p.m. Acting-Chief Daigle made his second recommendation to the commission to promote detective Janet Bouchard to rank of Sgt. She's been with the Hooksett Police Dept. since 2005. She does the math, she has no write ups. Her work ethic is second to none. Regarding the Bank of America robbery, the head of FBI, K. Ramsey said it was excellent dealing with her work. She makes sound decisions as the OIC fill-in.

At 6:19 p.m. Comm. Scherer made a motion based on Acting Chief Daigle's recommendation to promote Det. Janet Bouchard to rank of Sgt., effective Monday, April 2, 2012, seconded by Comm. Karolian. Unanimous.

Captain Daigle submitted a personnel action form for Kaitlin Johannson to the commission.

At 6:20 p.m. Comm. Scherer made a motion to seal the non-public minutes, seconded by Comm. Karolian. Unanimous.

Comm. Scherer made a motion to come out of non-public session, seconded by Comm. Karolian. Unanimous.
