#### SUPERINTENDENT'S REPORT

**GOLDEN GATE GENERATOR** - Supt. Kudrick told the board that the generator AAA Pump wants to give the plant is a 20 kw unit that only has 22 hours of service on it. It may even be small enough to fit in the existing structure, which would eliminate the need for any new construction, but he will have to check the electrical standards.

**Ph LEVELS** – Supt. Kudrick has mentioned before about the trouble with maintaining a proper ph level. After speaking with Ron Breton about the GE wastewater, he found that if GE changes their procedures in how they treat their waste before it comes to the plant, it could benefit the plant's ph levels. They will begin a 30 day trial to see if this alleviates the problem.

**PLANT UPDATES** – The boiler is once again having problems. Chairman Baines asked if the warranty could be expanded, and was told that as long as all the problems were documented, there shouldn't be a problem. – The Bar Rack and Stop Gate could take up to 18 weeks to change the size of the screen and install a slide gate. – The washwater pump is still having problems, another one is being ordered so that it can replace the non-functioning one when it needs to be serviced without any down time.

**DRAFT BUDGET** – Supt. Kudrick told the Board the budget is basically finished with a few clarifications needed from Guy Beloin.
