**SUPERVISOR OF CHECKLIST (SoC)
MINUTES
Hooksett Library
Tuesday, March 23, 2010, 7PM**

CALL TO ORDER

Bob Ehlers called the mandatory meeting to order at 7:00PM, declaring a quorum present. The meeting was scheduled to be held between 7-7:30PM.

ATTENDANCE

Chairman Bob Ehlers, Sally Humphries, Mike Horne

No public sat in or provided input, other than voter forms being reviewed/processed.

APPROVAL OF MINUTES

The minutes of meetings held on February 6, 2010 were reviewed. Motion to accept minutes as written: Bob Ehlers, 2nd by Bob Ehlers. Unanimously approved.

OLD BUSINESS

A work session was held to review the election results scanned into ElectionNet done for the Senate Primary (quality check) at Sally's home on Wed., Feb 10th. All three supervisors were present.

On Tuesday, February 16th Senate District 16 elections were held at Cawley School. Official Supervisor of Checklist business conducted (taking registrations, changes to political parties, etc.) with actions made in ElectionNet. An internet connection was available to connect to ElectionNet in Cawley School, thanks to the school IT person.

On Tuesday, March 9th the school elections/budget polls were covered by at least one supervisor the entire time. Official Supervisor of Checklist business conducted (taking registrations, changes to political parties, etc.). No minutes were taken and no other checklist business was conducted. Maintenance of many voter records was accomplished (sorting inactive voter cards from active voter cards). A quorum was present when reviews and approvals of actions were made.

NEW BUSINESS:

Town Deliberate Session: Bob said it had been move ahead one weekend to April 10th and to IPM. Bob and Sally can be there to check in voters, Mike will try to reschedule conflicts and be there to help at the beginning.

The checklist from March 9th School elections/vote were signed. Bob had scanned the results into ElectionNet.

Supervisors then reviewed pending changes of voter records from Feb. 16th and March 9, comparing printouts from ElectionNet with paper records.

- Seventeen voters had moved out of Town and needed to be removed from the checklist. Motion to do so by Mike, 2nd by Sally. Unanimously approved.
- 10 voter changes required supervisor approval (1 removal, 9 other actions). Motion to approve by Sally, 2nd by Mike. Unanimously approved.
- The lists acted on will be attached to the minutes for future reference. Mike volunteered to reflect approved actions in ElectionNet

Sally will picked up 4+ forms at Town Hall and process for next meeting.

ADJOURNMENT

Mike motioned to adjourn, 2nd by Bob. Unanimously approved. Meeting ended at 7:50PM.
