Staff Report Selection of Financial Institution for Fire Tanker Lease **April 11, 2012**

Background: With the passing of Article #5 in May 2011 Council as the authority to enter into a 7-year lease for a Fire Tanker truck. On September 28, 2011 Council approved the bid from HME Lakes Region Fire Apparatus for a 2012 International 2500 gallon fire tanker at a cost of \$334,000.00.

Discussion: I requested interest rates for a 7-year lease from the following financial institutions:

Institution	Rate
Citizens Bank	3.29%

Municipal Leasing Credit	2.84%
People's Untied Bank	2.66%

People's United Bank's rate is only good for two weeks, so there may be a slight change in the final rate, since it is anticipated the delivery date will be April 30th.

Fiscal Impact: The Hooksett voters approved financing \$340,000 at 4.5% over seven years for a total cost of \$396,984. The Town will actually finance \$334,000 at 2.66% for a total cost of \$366,422. A savings of \$30,562 for the life of the lease.

Recommendation: Motion to lease the Fire Tanker Truck with People's United Bank.
