My name is Robert McGuigan and I'm writing to you on behave of the Rolling Thunder © organization.

Rolling Thunder © was incorporated in 1995 as a class 501(c) (4) non –profit organization which now has over 90 chartered chapters throughout the United States and members abroad. The main mission of Rolling Thunder© is to educate the public that many American Prisoners of war were left behind after all previous wars.

To further our mission an idea was born, and acted upon, in public municipalities, private corporations, and at public venues, a chair was dedicated as a Memorial to the POW/MIAs. This Memorial chair is usually placed at a place of honor in the facility, and is painted black, with the POW/MIA insignia placed upon it. This Memorial chair should remain empty, signifying the absence of the POW/MIA member. In addition a plaque or letter should be included with the Memorial explaining the purpose of it, and to remind everyone of the over 92,000 POW/MIAs still missing.

A Memorial chair like this placed in a public venue for all to see is a tool to further the education value and the remembrance of the Veterans that have served and are still missing. The Memorial chair also helps the family and friends of the missing, to know that we have not forgotten them or their loved one.

This process has been carried out locally at various Stadiums in New Hampshire and Massachusetts, as well as several towns in New Hampshire, and over 40 towns in Massachusetts. Goffstown was New Hampshire's first town to install a Memorial chair in the Town Hall. Auburn installed a Memorial bench in the town's common area, while both Manchester and Nashua, installed a chair in their City's Stadium.

My request is for the Town of Hooksett to support our effort, and to place a similar Memorial chair at a town facility such as the Town Hall. I feel that the Town of Hooksett could benefit greatly by providing this service to all Veterans and Veteran organizations, as a showing of the Town's dedication to all that have served in the Military, who are currently serving, and who will serve in the future.

The Town of Hooksett could use the unveiling/dedication of the Memorial chair as a great media event to show how the town supports the military, and Veterans. The constant display of this Memorial chair could be referenced many times by the town in various media events, to emphasize how the town supports the Veterans.

While other facilities were able to place the Memorial chair in a place of honor, that would not be a necessity. It should be placed in a position where it is visible to as many people in as possible.

We believe that the cost to do this is minimal. The only requirements are a chair to be used in the Town Hall, preferably a chair that has some town history, a few flags to flank the chair, and a plaque which explains the purpose of the Memorial. It need not be a new chair, preferable painted black with the POW/MIA logo applied..

We would be willing to work with the town and provide as much assistance as we could, to reach this goal.

I have enclosed a few pictures that were taken at Goffstown and a few other Towns memorials in Massachusetts as an example of what the chair would look like.

# Staff Report Environmentally Snow Melt December 18, 2013

# **Background:**

The Town uses on an average of 2500 to 2800 tons of salt per year. This gets applied usually three time per average storm and on snow dustings without any accumulation we could go out at least six times. This environmentally safe chemical will be added to the salt.

#### Issue:

Last season we put down 2800 tons of salt. With the additive we could possible save 20 to 30 percent of salt depending on how we install it. the price for this is \$19.00 per ton.

#### Discussion:

I have checked with other town that have been using this for some time and back the item. They not only are saving salt but they are saving man hours. With this we can pretreat before a storm and save on overtime. We can also save on call ins, example once we finish a storm and drop our final treatment, at times we have to return by early morning for freezing has occurred over night. With this, we should not have to return in early, it should take that call in away on most occasions. I have received two bids from the only two companies that provide this particular chemical. One was for \$21.00 per ton the other was for \$19.00 per ton.

#### Fiscal Impact:

Could save the Town up to 30% in cost of salt. On a \$140,000.00 salt budget we could save \$42,000.00, and save on the overtime of the crews along with fuel and wear and tear on the vehicles.

### Recommendation:

I would like to have a purchase order for the \$42,000.00 to use as we treat the incoming salt, which is at \$19.00 per ton to treat. This would give me a PO for the season to work off of. With the savings I do not think we will use the entire amount. I would recommend that the council go with N H ice melt for the \$19.00 per ton.

# Proposed Change to Town Ordinance #00-28 "Administrative Enforcement of Parking Violations" December 18, 2013

<u>Background:</u> On January 22, 1997 the Town of Hooksett adopted Town Ordinance # 00-28 titled: Administrative Enforcement of Parking Violations.

<u>Issue:</u> To change the violation fine amount for "Disability Place" parking from \$50.00 to \$100.00. After 7 days the fine amount would change from \$75.00 to \$200.00

To change the violation fine amount after 7 days for "Night Parking Prohibited" from \$15.00 to \$30.00.

<u>Discussion:</u> The current Town Ordinance #00-28 titled Administrative Enforcement of Parking Violations was adopted back in 1997. At that time all other fine amounts in the ordinance violations double in amounts after 7 days with the exception of the above listed violations. The change proposed is to bring the two above listed fine amounts in line with the other violation amounts in the ordinance. In the upcoming conversion of the new Police CAD/RMS program to be utilized by the Police Department, fine amounts need to be adjusted to the above listed amounts in order to be electronically tracked and billed in the new system. The proposed fine amount changes are the first to be proposed since the adoption of Town Ordinance in 1997.

<u>Fiscal Impact:</u> There is no fiscal impact to the town should the above listed changes be adopted. The result of the changes would be an increase in revenue to the town as the fine amounts in the above listed two categories would increase after 7 days.

<u>Recommendation:</u> To change the violation fine amount for "Disability Place" parking from \$50.00 to \$100.00. After 7 days the fine amount would change from \$75.00 to \$200.00

To change the violation fine amount after 7 days for "Night Parking Prohibited" from \$15.00 to \$30.00.
