Shall the Town of Hooksett raise and appropriate as an operating budget, not including appropriations by special warrant articles, the amounts set forth on the budget posted with the warrant or as amended by vote of the first session, for the purposes set forth therein, totaling \$13,055,472? Should this article be defeated, the operating budget shall be \$12,130,130, which is the same as last year, with certain adjustments required by previous action of the Town of Hooksett or by law; or the governing body may hold one special meeting, in accordance with RSA 40:13, X and XVI, to take up the issue of a revised operating budget only. Note: This Article does not include special warrant articles #5 through #34.

- M. Ruel, "I strongly support having the operational budget early on so as to prioritize the warrants."
- G. Longfellow requested changing the amount to identify the amount included for the Sewer budget.
- D. Savoie, "The warrant cannot be changed as mandated by law, however, a note can be added to identify the amount which is Sewer only."
- M. DiBitetto, "I think that may be more confusing to the voter."
- D. Savoie, "The Sewer represents \$931,000."
- M. Ruel, "I think it is important for the voters to understand all the numbers."
- P. Rueppel, "Why can't we put that information in the Newsletter?"
- M. DiBitetto, "We will do that, but the issue is do we need a note on the warrant article now."
- M. Ruel, "Note: \$931,000 (Sewer Department's budget) of the \$13,055,472 is not raised by taxes, but from sewer fees.

P. Rueppel motioned to approve the article with note change \$931,000 (Sewer Department's budget) of the \$13,055,472 is not raised by taxes, but from sewer fees. and with the default budget to be added upon approval. Seconded by M. Ruel. 7 - 1 (M. Jolin) motion carries

The total cost of this fire engine lease, if acquired at an annual lease payment of \$61,588 will be \$431,113.*

- P. Rueppel, "When a firefighter gets called in we need to pay 3 hours. By the time they get to the station, they are no longer needed but still are paid for a minimum or 3 hours."

- D. Savoie, 'No, but you can zero it out on the floor."
- M. Ruel, "You can also motion to reconsider."
