Minutes from June 16, 2009 Fort Meadow Commission Meeting

7:29 PM - Meeting called to order in the Marlborough Public Library In attendance:

- Marlborough Commissioners Thomson and DelGenio and agent Gould
- Hudson Commissioner Kaczmarek and Agent Jones
- No Marlborough residents and one Hudson resident, Jason Galofaro attended

Minutes:

- Minutes from May, 19 2009 meeting accepted with one amendment regarding Coverage schedule change not passed (see in blue on May minutes)
- Triathlon discussion:
 - o All approvals are in place
 - Agent Gould to make No Wake signs for event
 - Commissioner Thomson to provide letter to be distributed to residents
- INT League insurance binder:
 - City solicitor has approved the insurance binder
 - o Event approved for June 27-28, 2009
- Weed Control:
 - o Treatment scheduled for tomorrow, June 17, 2009
 - No boating on reservoir (except east basin) or use of Hixson Launch for June 17-18, 2009
- Buoys, docks, jump and boat house:
 - o Agent Gould to make replacement buoy labels
 - Raft on reservoir near Elizabeth Road needs to be moved closer to shore, Commissioner DelGenio to speak with owner. FMC agreed to no longer offer residents the option of moving commission buoys on their own, they must contact the commission if there is an issue with placement. Commissioner DelGenio will make this known to owner.

- 98 Paquin Drive:
 - City to investigate the debris and possible trailer storage on city property, Commissioner DelGenio has placed a call to Councilor Clancy.
 - Agent Jones to stop by and reiterate the rules with the owner and stress the need for compliance.
- 30 Reservoir Street:
 - Boats and jet skis have been operating out of this residence in violation of several Commission rules and state laws,
 - Commissioner Thomson has paid them several visits to date.
- Coverage schedule:
 - Motion to maintain primary and secondary contact was approved by Commissioners Thomson and Kaczmarek with commissioner DelGenio not in favor.
- Environmental police to be called to come to lake.
