Fort Meadow Commission Meeting Minutes

7:00 PM - Meeting called to order in the Marlborough City Hall.

In attendance:

- Marlborough Commissioners Thomson, and DelGenio(called in, call dropped by host after 21 minutes)
- Hudson Commissioner Kaczmarek and Agent Pelletier

Minutes:

- Minutes from December 30, 2010 meeting reviewed and approved by Commissioners Thomson, DelGenio and Kaczmarek.
- Marker Buoys
 - The Paquin Drive Beach Association complained that boats and personal watercraft were coming too close to shore and endangering swimmers. Motion was made, seconded and passed to approve of the Paquin Drive Beach Association purchasing and placing marker buoys 50 feet from shore to designate their swimming area.
 - Commissioners agreed to place marker buoys for the season in the usual locations on a date acceptable to commissioners.
- Hixson Boat Launch
 - Commissioners agreed to assemble and place the Hixson Boat Launch dock for the season on a date acceptable to commissioners
 - Commissioner Thomson agreed to contact the Recreation Department Director regarding start date for the boat launch attendants and added supply of boat launch gate keys.
 - Launch keys were issued to several early fishermen
- Docks
 - Resident's Non-Permanent docks were discussed. It was stated that when they were left in the water over the winter they were violating municipal property and the ice damaged them. The ice damage resulted in debris that became a hazard. Motion was made, seconded and passed for commissioners to monitor the situation and Commissioner Thomson would contact the City Solicitor to arrange support if violators required legal action.
- Hudson Agent
 - Gary Pelletier was nominated and approved as Hudson Agent through January 1, 2012
