

Hudson Master Plan Public Forum

Open Space, Recreation, and Historical Resources Summary Report

On Monday, January 14, 2013, the Town of Hudson convened a public forum to discuss the topics of open space, recreation, and historical resources for the 2013 Master Plan Update project. Approximately 50 people attended the forum, which was held at Town Hall from 7:00 PM until 9:30 PM. In addition to members of the public, the forum was attended by Michelle Ciccolo, Community Development Director; Linda Ghiloni, Parks and Recreation Director; Jennifer Burke, Planning Director; Kerin Shea, Community and Economic Development Assistant; Rodney Frias, Chair of the Master Plan Steering Committee; members of the Master Plan Steering Committee; and representatives from the consulting team (Geoffrey Morrison-Logan, Alyssa Sandoval, AICP, and Nicole Benjamin-Ma). The following sections provide the results from the interactive group survey during the presentation and the results of the break out group discussions.

9. What should Hudson's first priority be to protect historical resources?

- 3. Protect historic landscapes/scenic views (33%)
- 4. Protect scenic roads and stonewalls (4%)
- 5. Protect and enhance connections to Hudson's cultural history (18%)

The following is a summary of the reports from each of the groups.

1. How can the Town make the public more aware of the open space, recreation, historic and cultural resources in Hudson?

Group 3:

- 2. Given what has been accomplished to date and what still needs to be done, discuss the main priorities for the Town over the next few years.

Group 1:

- Moulton Field
 - Needs improvement
 - Better lighting
 - This park is an asset because there are few outdoor basketball courts in Hudson
 - Farina Field (Cox Street)
- Obtain easements for walking loop at Portuguese Club
- Canoe access on Assabet River
- Improved motorboat ramp on Fort Meadows Reservoir
- Need a dog park
- The Town should investigate whether Hudson Catholic would be a good location for a Community Center. There is a need for publicly accessible indoor recreational space.

Group 2:

- Dog park
- Prioritize existing parks
- How can we answer if we don't know what is "out there"
- Neighborhood parks
- Larger parks (Danforth, Rail Trail)
- Empty trash cans!
- Apsley Park Implement existing master plan to rehab! boat launch

Group 3:

- Danforth Park maintenance seems lacking

- Additional trails Danforth, Wells, Gates (not Hudson)

- Sidewalk on Chapin and River Streets
- Poison ivy maintenance
- Professional maintenance at Tripps Pond
- Trail all the way around Tripps Pond
- Gates Pond dog park (not allowed) need better dog control since this is a Town water source

3. Where should the Town focus its efforts in providing better connections between parks and adjacent neighborhoods and between parks and open spaces?

Group 1:

• Cultural District Designation – this would allow Hudson to provide better connections between open space, arts/cultural resources, and historical resources
