### Housekeeping:

\*Peter has heard nothing back from the Town Manager about the transition plan, but will check again later.

\*There has also been no E-mail responses from Bill concerning any new information. Later, Bruce received replies from earlier Emails.

\*Joan has come up with an idea that a firefighter should travel to the disable's homes and make sure that their smoke detectors and carbon monoxide detectors are working properly. Peter is going to speak with Captain Thomas for more insight.

### Current Projects:

#### A Street:

\*Cavanaro Consulting has submitted a design proposal to the Town Manager.

#### DCR:

\*Overall, three letters have been sent to this party. Matt Tobin is the manager of the Dcr and Bruce has recently spoken with him.

#### Parking at the Beach Ramp:

\*Matt Tobin states that the signs are going to be fixed. Bruce reminded him that the pavement still needs to be marked.

\*Beach parking- The pavement is partially marked. Two parking spaces at the beginning of the beach have been requested. A curb cut will be needed.

#### High School:

\*The auditorium is up to date and all the work is completed. A few minor touch ups may be needed. As soon as the punch list is complete a draft will be forwarded to the architect. Signs still need to be installed. There is a curb cut that is not compliant near the baseball field.

#### Senior center:

\*Joan and everyone are hoping that the \$800,000 CDBG Grant is issued. Updates for the senior center can be included in the grant request. It was suggested that the seniors themselves must form a group to advocates for the needs of the seniors.

#### Tedeschi's Food Shop:

\*The project is in process, as the existing sidewalk has been jackhammered.

#### Hingham Savings Bank:

\*The job has been completed!

#### CVS Cohasset:

\*Joan has hear no response, there is still an existing problem.

#### Rockland Trust:

\*The job is completed!

**Dunkin Donuts:**

\*The commission knows that there are renovations to be done, but there is no specific date yet.

**Steam Boat Wharf:**

\*The commission is still waiting on revised architectural drawings.

**Liason to the Chamber of Commerce:**

\*Jim would like to attend and upcoming meeting in Cohasset for the commission. Jim has already attended a recent meeting on the 20<sup>th</sup> of November.

**Commuter Boat Shelter:**

\*Jim has questioned if there were any handicapped parking spaces close. Peter replied that there was four or five spaces right in front of the school.
