"At a duly posted public meeting the Town of Hull DCR Re-Use Committee held on January 26, 2011 the Committee voted to support the Town's request for a technical assistance grant from the Metropolitan Area Planning Council through their District Local Technical Assistance Program. The purpose will be to assist the Town in creating a development framework by updating the "Nantasket Focus Area Study" (2004). This update will be consistent with sustainable development principles and include but not be limited to recommendations for zoning amendments to help revitalize the area including the Department of Conservation and Recreation property."

Motion to approve this suggested motion: Joan Meschino. Seconded by Max Horn. Committee voted unanimously. Result: Motion Passed. Community Participation Program - 6:40 P.M. Discussion

The structure of the community participation program was discussed. Facilitated by the members of the committee, it was suggested that the public break out into clusters of groups. There will be a facilitator, a speaker and a writer for each group. They would come up with a list of ideas of what kinds of development they would like to see. Then the top five would be voted on at each table, and posted on the wall. This process will draw out the top priorities as envisioned by Hull's citizens. March 5th and March 12th were two possible dates that were discussed for the Community Participation Program.
