Meeting was called to order at 6:05 p.m. in Hull High School Second Floor Exhibition Room.

Judith Kuehn, Director of Student Services, presented the following information on special education requirements and costs:

- 23% of current school budget is for special education
- Free and appropriate education
- Least restrictive environment
- Continuum of services must be provided
- Special education goals:
  - 1. Increase capacity of the current special education programs
  - 2. Reduce the number of students placed out-of-district
  - 3. Create programs within the Hull Public Schools across the district

Learning Environment that is Adaptive and Friendly (LEAF)		
Grade Level	Program Implemented	Enrollment
Kindergarten – grade 2	September 2005	September 2009 – 8 students
Grade 3 – grade 5	September 2007	September 2009 – 6 students
Grade 6 – grade 8	September 2009	September 2009 – 6 students

Teaching Independence and Decision Making through Educational Support (TIDES)

- Six South Shore Educational Collaborative Classrooms in Hull Schools reduces transportation costs and adds ability to contract services or deduct from tuition (400 per classroom a month)
- Seven students will attend South shore Educational Collaborative Mini School programs in Hull in the fall of 2009
- Summer of 2008 one student transitioned from out-of-district to LEAF grades 3 –5
- Summer of 2008 one student transitioned from out-of-district program to South Shore Educational Collaborative at Jacobs School
- Fall of 2009 one student will transition from out-of-district program to LEAF kindergarten grade 2
- Fall of 2009 one student will transition form South Shore Educational Collaborative at Jacobs School to LEAF grades 3 5
- Twenty-six students are currently attending in our-of-district schools (two cost share with other towns)
- Cost to send a student to South Shore Educational Collaborative in FY09 was \$38,194 \$46,635
- Circuit Breaker = Foundation level \$37,328 % of Net Claim returned to districts
- FY09=72%; FY10=28%-42% (has not been determined)
- Transportation is additional cost (no assistance form circuit breaker)
- Estimated FY10 transportation cost = \$333,575
- Early childhood programs are mandated to have in place by a child's third birthday.
- How are priorities for special education established:
  - o Driven by population of students and their needs
  - o Changes in evaluation instruments
  - o Professional development/training needs
    - \$133,675 Medicaid reimbursement was returned to the Town in FY09
    - Time consuming for special education staff to meet requirements
    - Return directly to district in FY10

- Staff feedback at end of year
- Feedback from parents after re-evaluations
- Required by DESE
