Comments: We will continue to take notes that will help us remember the context of our votes.

Comments: Town Meeting Article commentary discussion. Charleen presented a draft of a commentary we might use for the warrant. How much detail should we include in the commentary? Do we say how much the Jacobs School impacts our tax bill? Or how much has inflation affected our tax bill now that more years have passed? It seems that the circumstances exist that this will be simply an authorization to spend this money but it does not create a debt-exclusion automatically. When the debt actually hits us then we will need to decide if we want a debt-exclusion or to reduce services when the debt is due.

Chris McCabe stated that we will have to issue bonds for the Jacobs School project later in the time line since it is a full year late.....BAN is easier to arrange since they are at a lower % schedule. We will not be paying debt

and principle for all 3 schools at the same time. There are variables that will affect the way the tax levy will be applied to individual citizens. Chris McCabe pointed out that we can only project what it will cost based upon what we know now.....we don't know what the borrowing rates will be. We discussed the way in which we will use the letter that is included in the warrant. This is the same letter we have been inserting into the warrant for the last few years.

Jim O suggests that this letter must be clear as to why we might have to have an over-ride or a debt exclusion.

Motion: To add a sentence to the letter for the 6-22-06 Warrant. In the next to last paragraph add the following sentence to the end of this paragraph. "The question before the Special Town Meeting on June 22nd, authorizing the expenditure of an additional \$2.8 million will have a minimal impact on the average tax bill. A debt exclusion will be necessary regardless of whether the \$2.8 million is authorized or not if we are to avoid a reduction in town services".
