• Budget Presentation – School Committee/Final Budget Presentation

Jim Canavan presented the School Committee as well as those school personnel in the audience. A reduction of 10 positions will be eliminated within the school department as a result of this budget.

Paula Delaney made a presentation for the entire school budget that will be level funded.

Paula made the comparison of the school system to a business. School system has more than 200 employees. Safety is critical for all. Transportation is another large piece of the school business. We transport about 1,033 students each day. The schools feed 542 lunches to students each day. 11% of the students get a breakfast also. The school department must comply with about 103 directives from the Department of Education but do not include Special Education. We are not permitted to turn away any client (student). SPED placement can range from \$37k -200k per year. We must also maintain the buildings. We use grants to supplement our budget allowances even though these grants are decreasing each year.

Initial budget request was \$13,603,191 and today we come in with \$13,105,919.

With this reduced budget comes some risks:

Staffing, class size, after school programming, collective bargaining, deferent of maintenance initiatives.

Jim Canavan pointed out that the reading program presently being used is not 13 years old. It is a 7 year old program.

Grant monies are not reflected in the budget, it only shows the amount not covered by the grant.
