Working Group Updates Schools

OCT 23 is General Govt 6 pm Oct 11 is School group 5:30 pm

General Govt

Schools met and vetted the 5 year financial plan. Largest discussion centered around New growth.

2009 is 800,000 – 1,000,000 in the red 2010 is 2.5 -3 M in the red

Discussion held with potential Override or debt exclusion for 2009 or 2010. The current thought would be to use good solid fiscal management in 2009 before looking for override or Debt Exclusion. The budget process and time will dictate the strategy and we move through the process.

Jim had a concern about surrounding towns being sued. Example given was Rockland having a minimal manning clause in the their contract.

Charleen mentioned the MTA site about Prop 2 ½ legislation. DOR also has good info.

Dennis asked what was required of the town. Phil ran through a laundry list of the requirements of the town. Schools, Police Fire, certain town offices, etc. Phil warned that we carefully have to navigate this notion as every service has a constituency and there are quality of life issues.

Dennis spoke of using our resources more wisely. Example of Library being housed in a school building. Phil discussed why that wouldn't work, but certainly some resource management could be done.

Parcel of land Showboat parcel

Update based on questions of John Schmid

Parcel voted to authorize the town to accept parcel as a gift.

Mr. Kiley (developer and owner of parcel) wished to gift the parcel to the town.

There were title issues earlier based on a dispute with a business partner. Eventually, he was able to clear the title, but he had subdivided to meet existing zoning. As a gateway site to the town, people wished to see the the site developed responsibly or not at all.

Maintenance and upkeep would be done through proposals from various groups to keep tidy and possibly have plants placed.

John asked how can we accept a parcel that is not the same as town meetings vote. Parcel is just under 38,000 square feet. Bulk of remaining parcel is waterfront district.

Jim spoke of the history to how the land was subdivided and portions merged with an adjacent lot based on zoning.

Dennis Zaia offered some history around why we considered the acceptance of the parcel back in 1999. Enjoy Hull group was a major proponent at the time. The intent was to make a gateway property with little impact to development and community.

Jim Tobin asked if the Selectman had already voted to accept the gift. This had be accomplished at the last meeting. (September 28, 2007).

Phil Lemnios is taking the opportunity to accept this before the developer takes back the offer.
