Dr. Tyrell presented the schools budget beginning with the Maintenance Budget. These numbers displayed a budget that would maintain level of services or slightly increase from previous year.

Dr, Tyrell discussed with the AB the various Federal and state grants that are being funded for the school in 2007-2008.

John Schmid asked is the grant figures were funded for this coming budget cycle.

Dr Tyrell answered that they expect a level funding of these grants but it could come in less and the programs would have to be visited and her budget slightly reworked.

Dr. Tyrell presented various enrollment numbers for classes, athletics, transportation and food services.

Last year had a staff reduction of 7.2 positions. This year we may see a similar reduction.

This year a number of items have been realigned to charge cost to schools rather than the central administration.

Dick Kenney asked how these are budget for FY09. Jim O. followed up asking if all departments were revisited.

Dr Tyrell discussed some activities being done to increase enrollment by school age children not attending Hull Schools.

Principal Jon Ford discussed some figures on school and student assessment over the past year.
