Kenberma overlay parking

David Kellem presented the Riddles Plan for expansion and the need for an Overlay District Zoning change for part of Kingsley Rd.

Any proponent for this type of Expansion must go through the Planning Board Site Plan Review process. This would include issues such as drainage, traffic controls, Hours of use of a parking or delivery area, vehicle size.

Holly Preston presented the opponents View of the Article citing issues with delivery trucks and flooding. Jill Decosta Spoke of earlier non compliance of Deliveries in the area.

John Schmid asked if the Bank and insurance Lot would be moved into compliance.

This Proposal before us today was really site plan review issues and would encourage abutters to be present if this article passes at Town Meeting.

Planning Board Did

Dave Clinton asked about hours of deliveries.

Recycling (2 times a week) Can be flexible.

Rubbish (3 times a week) Can Be flexible.

Hour of delivery restrictions may be looked at with Site Plan review.

Phil Lemnios asked if the creation of the district automatically approves the project.

This is NOT the case. Site Plan Review Process will be instrumental in placing restrictions.

The core question for Town Meeting is... "Do we wish to create an overlay district which will force business to go through the site plan review process?"

Dennis Zaia asked if the Site Plan Review Process can include consequences to breaking agreements made.

Pat Finn States there are enforceable actions when dealing with Zoning. He also stated that this project will bring Existing Non Conforming lots into compliance. Post office is Federal property and not subject to our Zoning By-Laws.

Harry Hibbard states the Planning Board Process is the best vehicle for addressing the abutters concerns.
