Dennis states that AB should reaffirm to BOS to revisit the GIC involvement with Town Employees.

AB agrees to send a letter to request the BOS direct TM to enter in negotiations for adoption of the State Health Insurance program (GIC).

Charleen has a brief discussion with TM about looking at a couple other scenarios seeing the Market conditions and the Commonwealth need to borrow currently.

Jim Tobin asked whether there should be a new scenario drafted that only includes a Debt Exclusion for School Debt.
