John Schmid discuss the DLS offer for Financial Management Assistance. They have openings as of September/October range.

Dick Kenney discussed a topic that came up at the Dept of Revenue DLS training session on June 5. The BOS with the Approval of the AB can make year end transfers between Departments as long as each amount does not exceed a 3% maximum of the departmental budget. This ruling pertains to every account but the school department.
