## **Report or Budget Sub-Committee**

Meeting Tomorrow to finalize the report of the financial state o affairs to 2010 \$1.9 million

Cumulative of \$6+ million by 2014.

Decisions need to be made by selectman needed to decide ballot questions and town meeting referendums.

Town meeting may require two contingent budgets be prepared in case an override or debt exclusion does not pass.

Several options are being considered: See draft of Financial Committee report.

Charleen asked what scenarios mean with regards to Stabilization Fund

Only the one in where a one time override would be passed. None of the other scenarios require draw downs to Stabilization Fund.

Fees discussion was held Chair read an email with his thoughts on how fees should be handled.

Dennis states it is important to recognize the Selectman must make the decision on how to handle the Question of Override/Debt Exclusion.

Members present relayed that the process has been very thoughtful and the committee worked well to present a Draft Report that is useful to the BOS to use in its decision making.

Jim Canavan mentioned that the AB and BOS might want to push the Budget schedule a bit to get data earlier that January.

Dennis Z asked the AB make a clear statement to the BOS to end with a product that will be clear to the citizenry: an easily understood plan.

Jay Polito discussed presenting a simple set of options. Option A or Option B, not XYZPDQ.
