Town Manager Report

Budget update for FY10.

We are moving to plan. Had some heavy beach cleaning days due to storms.

We will be running into potential budget needs with beach cleanup in the next few years due to capacity or dump.

- Police and fire at expected staffing. Police are down 1 officer. Had a retirement to help save a position.
- Rep. Bradley has instrumental in getting a trust fund set up for increased parking fees to help defray costs to the town for emergency services
- Building department is stress, but handling things.
- Chair asked if the Health Department could handle the Flu Clinic for shots. We are positioned OK for this.
- The Veterans budget is really the only question mark budget is at 90K and we are on track to spend twice that.
- Community Outreach

Charlie Ryder asked: Is the outreach worker still employed?

Yes. Town Meeting spoke. Town Hall listened.

Commonwealth has their own budget issues and aid to towns may be less than expected. We have prepared for this. We have \$300K to cover any shortfall in aid if we need to use it.

The state provided a grant for the Regional Dispatch center. We may be able to see this operational by next summer - Jan of 2011.

John Schmid asked about regionalization with any other departments. We have conversations with other communities and are looking for synergies.

Jay asked about staffing of summer officers. There seemed to be less parking enforcement in some areas of town than previous years. Town Manager will check on this.

Dick Kenney asked about negotiating out the Quinn Bill costs. This would seem to be difficult due to successor clauses.

We will go to arbitration on the Health Care Split with the HTA. First hearing is 2.5 months out.

Jay asked about the ramp at A St. Hope to see installed by Dec 1, 2009

Financial Planning committee has been reconstituted. We need to name two members.

Frequency of meeting may be bi-weekly for 3 or 4 months.

Maybe less depending on the objective of the group.
