Town Manager

Town Manager reviewed the agendas for AB meetings In March. He also distributed the Draft Town Warrant language for 2012 Town Meeting. This is a relatively light warrant (29 articles) and so far there are no Zoning Articles.

Board of Selectmen is soliciting names for the Government Study committee.

Town Manager presented budget items as follows:

- Insurance
- Townwide account
- Retirement
- Debt Service
- General Govt Services

Insurance

FY12 Worker's Comp is already over budget. (\$7500) Town Accountant will come to AB for a transfer later this year. We may already be under budget for this item for FY13. When asked further about this, the Town Manager expressed that FY13 will likely be in with the FY13 budget

Fuel Reserve is higher compared to past years actual figures. We are holding steady from last year. To date expenditure is \$113,000 (33,000 gallons). With \$5/gl, WE WILL BE AT \$292,000 FOR THE YEAR. Fuel Reserve also includes maintenance of vehicles.

Townwide

Abandoned Property Services line item is new. This allows the Town to deal with dilapidated buildings. Question was asked what \$20,000 buys the Town? Town Manager stated that it is a plugged number to see what the program may need. This give the enforcement teams some resources to begin this program. Money will eventually flow back into the Town through a lien procedure.

Further questions asked about what constitutes an abandoned property. Town Manger stated that there is a legal process that defines this.

Debt Service

Interest and Fees on temporary borrowing are for the Fire Engine, Sewer Project and Dredging.

General Government Services

Accountant is level funded from last year.

Town Buildings is maintenance of Town Hall predominantly.
