Town Counsel: Jim Lampke

Town Ownership of former stations. Easement on the actual bed. State (DoT) must approve any building on the bed. Would cost likely hundreds of thousands of dollars for determine legal/parceling/cleaning issues.

Discussed environment condition of land. Former railroad dumping.

Mr. Kaplan pointed out illegal dumping takes place today.

Bob Carney points out such licenses as current granted are revocable by BoS with 30 days notice.

Mr. Finn asks question...Is this a zoning Article? Unclear.

#### **ARTICLE 26:**

Jay Polito: What is the estimated cost of retaining this special counsel?

Mr. Kaplan – says checked with Law firms and guesses \$5K - \$20K. J. Polito points out seems very low.

Deliberate on both 25 & 26:

Dave Clinton: Confusing. Waste of time. Perhaps refer for rewrite and bring back next year.

Ernie Minelli: recommends no action on Art. 25, refocus on the language. Unfavorable on Art. 26 due to no \$\$ called out.

Mr. Lampke: His opinion that the BoS has the full legal authority to do what it is doing.

TM: The way Art. 26 written, this special counsel not in best interest of town, operates outside BoS.
