- 1) How is the impact of the previous land transfer from the HRA accounted for in the Article?
- 2) How does the land transfer that was never completed get resolved?
- 3) Are there any Town-owned facilities on the property?
- 4) Are there private owners patched into the Fort Revere Park that could negatively impact the Article? Spoke briefly about the remaining articles to be scheduled for future meetings.

Article 1 - Crescent Seawall Article - Ann Herbst

- Discussed drivers for moving forward with Seawall project
 - Subject seawall protects 1 of the 3 escape routes out of Hull
 - Current seawall design causes debris to be transferred over seawall and into Straits Pond during severe storms (unable to dredge)
 - o Current seawall design causes ocean water to go into Straits pond (during severe storms)
 - Cannot wait to spring Town Meeting, since project must start by June 2016 in order to secure grant money
- Project is ~ \$6.75M, targeting grant for \$1.5M, \$1.5M subsidized loan at 2%, \$3.75M market rate bond
- Homeowners in close proximity to project will need to sign an easement to allow work to proceed
