- Hull Medical Center, Inc. (Lessor) formed in 1968 as a result of a student dying in a Hull school classroom
- Doctors in Scituate, Hingham, and Cohasset would not take patients from Hull
- Committee formed; resulted in the Hull Medical Center Corporation being formed; found doctors who were willing to work in Hull Part-time
- Currently there is no lease payment on the Hull Medical Center, Inc. property
- Manet Community Health Center, Inc. is a 501C (not for profit organization)
- Physicians who work there now work full time but cover multiple locations
- The Town assessor has a value documented for the property
- Many people who started the Hull Medical Center have passed away
