Town Manager Update

- Beginning to start FY19 budget planning; meeting on Nov. 16 with Board of Selectmen
- Busy summer with capital projects (road work on A H Streets)
- Hull received the grant for Bay Ave. East (including sidewalks to be installed on Northerly side)
- Riddles is in the process of transacting
- HRA is continuing to work with DCR for land swap

- Gun Rock Seawall project is progressing
- Hull is in the planning stages of land fill closure; trash that is being picked off the beach is still going to the landfill; meeting with DEP to work through preliminary planning; trying to get as much life out of the landfill as possible; no barrels on the beach has extended the life of the landfill; starting to plan for expenditures in 2020; looking to implement solar array on the landfill to help pay for cost of closure
- Planning for Health Care Costs
 - Hull is still part of Mayflower Health Consortium; Hingham decided to leave Mayflower consortium (Hingham's departure will not increase costs)
 - Maya Health Consortium is no longer openly accepting communities; much more difficult for towns to get in; newer participants typically have to pay higher rates
 - o In general, the cost of health plans is going up; deductibles are going up
 - Too early to predict a percentage increase for health care costs for Hull
- Budget
 - Looking at 2 2.25% increase for departmental budgets
 - o Capital Outlay Committee meeting again on Oct. 24
 - o Looking at \$200K increase in growth in tax revenue for coming year
 - o Payment to Charter school for Hull residents to attend continues to rise
 - Pensions are increasing by approximately 4% per year (Massachusetts one of few states that requires employees to pay into pension program)
- Community Preservation Committee
 - May be best for them to wait a year before they try to allocate capital towards needs
 - o Need coordinated effort amongst town groups to develop process for prioritization of projects
- Plan for Envelope Issues with Hull Schools
 - Have applied again for grant
 - o Hull school enrollment continues to decline

Committee Updates: Capital Outlay Committee, Beach Committee, others

- South Shore Vocational Tech (SSVT) held information sharing meeting; 6 parents of kids of high school aged children attended; 5 families from Hull attended an additional meeting held outside of Hull to get more information about SSVT
- Beach Committee conducted fall walk of the beach and documented legal and illegal openings and any damage to fencing
- Capital Outlay Committee no update; meeting again on Oct. 24
