The Commission also discussed the fact that the Town may soon be installing a new drain line on or near the location where the presence of fill has been an issue. Based on their site visit and the surveyed plans provided by the owner, the Commission concluded that the owner had not yet complied with an order to remove fill that was placed on the property in violation of an order of conditions. The owner was also advised that a change in the location of a previously approved stairway would require that the Order of Conditions be amended.

Issue an Enforcement Order requiring the owner to remove all fill placed on the property and provide a survey of the property showing that elevations on the property have been returned to their previous level.
