for work described as grading and drainage improvements.

Applicant: Ernesto Caparrotta Representative: Lenore White

J. Hass stated for the record that she had listened to a recording of the meeting of April 14, 2009 that she was not present for.

Mr. Caparrotta informed the Commission that he would like to withdraw the grading and drainage improvements from his Notice if Intent and proceed only with the Delineation of the Wetlands.

The Commission reviewed the proposals received for peer reviews from three firms (Comprehensive Environmental Inc., LEC Environmental Consultants, and Tetra Tech Rizzo). Mr. Caparrotta stated that he may have a conflict of interest with Tetra Tech Rizzo and also requested that the Commission hire LEC Environmental as they submitted the lowest fee.

7:50pm 36 ½ Channel Street, Map 1/Lot 43 Opening of a public hearing on the Request for Determination of Applicability filed by the Sarah Murphy for work described as replace existing stairs and landing and add a deck.

Applicant: Sarah Murphy

Ms. Murphy presented her project to include the construction of a 6 foot by 23 foot 3 inch deck in the rear of the house. The deck will be constructed on six footings. The existing stairs and landing will be replaced to match new construction.

The Commission and Applicant discussed spacing for the flooring and the Commission suggested a spacing of at least ¼" to allow water to drain. The Commission also suggested that the stairs have open risers to create less obstruction during storms.

It was voted to:

**Close** the Public Hearing, and **issue** a negative Determination of Applicability. The Determination of Applicability was **signed**.
