7:40pm Adjacent to 317 Beach Avenue, nearest Map 13/Lot 055 (SE35-1095) Opening of a public

hearing on the Notice of Intent filed by Town of Hull for work described as install leaching basin to

reduce street flooding.

Applicant: Joseph Stigliani

Abutters/Others: J. St. Pierre, C. (illegible)

Mr. Stigliani presented the project that is to include construction and installation of a leaching basin to be connected to an existing drainage pipe on S Street adjacent to 317 Beach Ave. The purpose of the new basin is to alleviate flooding and ponding of water in the area. The leaching basin will be made of basin blocks and will self drain. The basin will be installed in an area that is currently crushed stone and will be placed as close to the dune as possible without damaging the dune.

The Commission asked Mr. Stigliani if silt in the area would effect the operations of the basin. Mr. Stigliani indicated that the basin would be able to handle silt and will be cleaned on a regular basis. The basin will be covered with a standard manhole cover.

Upon a motion by J. Hass and 2nd by M. Horn and a vote of 6/0/0;

7:58pm 22 Cadish Avenue, Map 16/Lot 125 (SE35-1094) Opening of a public hearing on the Notice of

Intent filed by Glenn Frank for work described as elevate single family home and enclose part of an

existing porch.

Owner/Applicant: Kerrin Frank

Representative: David Ray, John Boyd, Stan Humphries

Mr. Ray began the presentation for the project and submitted revised plans. The project includes removing the porch from the rear of the home, raising the home and constructing a FEMA compliant foundation. The home

will be moved three feet back toward the rear of the property. A new porch will be constructed at the front of the house.

Mr. Humphries submitted a letter stating that in his opinion, the site is actually a drumlin rather than a dune, even though the area is mapped as barrier beach.

Mr. Boyd submitted a revised foundation plan showing that the porch will be removed.

A Special Condition will be added as follows:

- The Commission finds that the resource area is Land Subject to Coastal Storm Flowage. Although the property is shown to be on a barrier beach, the Commission finds that this location is not a coastal dune due to the evidence presented regarding the historic drumlin in this area.
- Upon a motion by J. Hass and 2nd by M. Horn and a vote of 6/0/0;

**710 Nantasket Avenue Map 17/Lot 118 (SE35-1096) Opening** of a public hearing on the Notice of Intent filed by Ozlem Martin for work described as single family home with associated driveway, utilities and grading.

Mr. Humphries presented the project to construct a single-family home. The home will be constructed on a concrete wall foundation with nine smart vents. Mr. Humphries reviewed a letter submitted with the Notice of Intent stating that the site had no characteristics of a functioning dune.

Mr. Humphries also submitted a draft site plan that indicated spot grades. After construction, the lot will be returned to the original grades.

A Special Condition will be added as follows:

- The Conservation Commission finds that the coastal dune in this location is not significant to the interests of flood control and storm damage protection.
- Upon a motion by P. Paquin and 2nd by J. Meschino and a vote of 6/0/0;
