pavers.

Mr. Ray presented the applicant's proposal to substitute a different brand of paver for the ones previously approved. Mr. Ray indicated that the approved pavers have been installed in two locations in Hull and have started cracking. Mr. Ray asked the manufacturer to produce a heavier paver of the same style and the manufacturer declined. Mr. Ray suggested Belgard Subterra, because it is a heavy (19 lb.) permeable paver that has an interlocking pattern. The pavers will have granite edging to prevent uplift in the case of overwash from a storm. The project eliminates 3,500 square feet of concrete. The Commission proposed a special condition as follows: The approved paver is Belgard Subterra. Installation and maintenance must follow manufacturer guidance to maintain permeability. No stone dust can be used.
