The Commission had conducted a site visit relative to a Request for Certificate of Compliance. Of concern is a cylinder type of structure that is located behind the house and not indicated on the as-built plans. Additionally, the as-built plans appear not to reflect the actual foundation. To prevent future disruption to the vegetation on the coastal bank, the Commission has suggested that the Owner place signage indicating that the area is a "protected conservation area". The Commission also noticed a supply of paver blocks and would like to know what the intended use is.
