7:45pm 7 Adams St., Map 19/Lots 102, Opening of Public Hearing on the Request for Determination of Applicability filed by Robert Knudsen for work described as above ground pool and deck.

Owner/Applicant: Robert Knudsen

Documents: 3 hand drawn sheets of pool and deck

Town of Hull Requirements for Private Swimming Pool – Building & Board of Health

Mr. Knudsen presented the project that is an after the fact filing for construction of a 32' x 16' deck on sonotubes and construction of a 24' round 52" deep above ground pool. In response to an inquiry from the Commission, Mr. Knudsen indicated on the plan that the pool was 14' off the rear property line.

The Commission informed Mr. Knudsen that any water drained from the pool must be drained into the sanitary sewer system and not into the storm drains or taken off site.

A Special Condition was added as follows:

- Pool water cannot be emptied into the storm drain system, but rather must utilize the sanitary sewage system.
- Upon a motion by P. Paquin and 2nd by M. Horn and a vote of 4/0/0; It was voted to:

**Close** the Public Hearing, and **issue** a negative Determination of Applicability. The Determination of Applicability was **signed**.

#### New Business:

Discussion of Request for extension SE35-1030, Spinnaker Island Yacht Club – The Commission discussed a Request for Extension for the Order of Conditions that will expire in October. Special Conditions were reviewed that called for various inspections. The Commission will conduct a site visit to view the conditions of the Wave Attenuator prior to taking up the request.

Question regarding gravel driveway – The Commission discussed policy on how to handle requests for removing lawn area and replacing it with gravel to construct a driveway. The Commission agreed that, under some circumstances, it may be permissible to do work of this type without requiring a permit.

Conservation Commission land – The Commission discussed the status of various parcels of conservation land.

Beach wall question – The Commission reviewed an inquiry regarding repair of a seawall.
