of Applicability filed by Joseph Casna for work described as install above ground pool.

Owner: James & Cheryl Rapoza

Documents: Mortgage Inspection Plan - dated 3/26/2014 - with notations

Mr. Rapoza presented the project that is to install an above ground pool with a stone edge surrounding the pool for drainage. A precast concrete pad will be used as the base for the filter. The Commission expressed concern that the ground is higher in the area of the proposed pool and informed Mr. Rapoza that there may be no runoff from the pool that sheds to abutting neighbors. Mr. Rapoza made a notation of the plan as follows: "Area around pool to be graded so as to be level with street and prevent runoff".

Upon a motion by P. Epstein 2nd by M. Horn and a vote of 6/0/0;

It was voted to:

**Close** the Public Hearing, and **issue** a negative Determination of Applicability. The Determination of Applicability was **signed**.

Documents: Existing & Proposed Conditions Plan - Nantasket Survey Engineering - dated Revised 4/19/2014

Mr. White presented the project that is to include removing an existing porch/deck and installing a new 10' x 24' deck of composite material. Seven sonotubes will be installed for footings. The deck will be approximately 5' high. The existing concrete pad under the deck will remain in place.

Close the Public Hearing and approve the project. The Order of Conditions was signed.
