Regarding a letter of appreciation for service for Vern Wood and Sarah White, N. Peyton informed the Board that he has submitted a request for a citation to the state.

N. Peyton will commit to representing the Board at meetings of the South Shore Coalition of MAPC. J. Duffy will attend the Thursday, June 20th meeting at the Hingham Town Hall.

The Board received the schedule of meetings for the second half of the year. They were encouraged to respond as early as possible regarding absences as there are only six members at this time.

The Selectmen have advertised seeking applicants to fill the vacancy on the Board. If anyone knows of interested parties, they should submit their information to the Selectmen before June 26. The Selectmen have received the memo from the Board requesting a joint meeting for the appointment of a new member.

The Board received forms /templates and sample conditions that are currently in use or have been used in the past as well as some samples from the Town of Sandwich. The purpose of receiving these forms is to begin the process of revising them to produce templates for use in future filings. The Board was encouraged to begin reviewing these documents for substance and format.
