Paul Gratta was present for discussion. He provided a brief explanation of the request for the minor amendment. The existing site conditions are not as expected and there is more ledge than previously thought. Because of this, the location of the sewer manhole must change. The trench would be the same length. J. Constable asked what the construction schedule is, to which P. Gratta said that he is currently working on one.

Upon a motion by S. Flynn a 2<sup>nd</sup> by H. Hibbard and a vote of 7/0/0, it was voted to approve the minor amendment, with the conditions as stated in R. Fultz's memo.

Zoning Bylaw Committee update

J. Duffy said that the ZBC did not meet last month due to quorum issues. A meeting is scheduled for February.

Community Preservation Act discussion and planning

- J. Constable said that the Board met with the Advisory Board on Monday (1/11/2016) and that overall, it was a positive meeting. At the meeting, a question was raised about if other towns had repealed the CPA. After researching the question, J. Constable has found that no community repealed the CPA after passing it. J. Paguin directed the Board's attention to a handout regarding CPA Questions (included in the record). The Board then reviewed handout provided by J. Constable which include a sample CPA Acceptance Vote Article. The Board discussed the provided information.
