Read and attest to the minutes from the January 25, 2006 regular Board Meeting as well as the Executive Session minutes.

Motion made by Leonard Colten seconded by Arthur Flavin to accept the minutes of the meeting held on January 25, 2006 with corrections as well as the executive session minutes for January 25, 3006. These minutes shall not be released.

After a review of Mr. Colton's account and testimony given by Mr. Colten, the notarized statement from Mr. Colton's physician, Akos Beszterczey, attached with a notarized copy of the medical response to PERAC dated 04/15/2004 and the copy of the letter sent to Dr. Beszterczey, from Mrs. Colten, which was also notarized and dated April 5, 2004, the Board felt that Mr. Colton provided proof and good faith in complying with

M.G.L. c, 32, §8 and therefore qualifies for reinstatement of his benefits for the period of May 04,2004 through June 30, 2005.

Review Medical Panel Certificate received on Gary Taylor.

Present for review was Leonard Colton, Marcia Bohinc, Gerald Ball, Maurice Murphy, Arthur Flavin and Retirement Administrator Jennifer Miller. Mr. Taylor was not present, but was represented by his Attorney, David DeCelles.

After a update of Mr. Taylor's history, the Board reviewed the original Medical Panel Certificate dated June 23, 2003, the Clarification request dated August 18, 2003 as well as the final Medical Panel Certificate dated December 21, 2005, in which all three doctors answered all three questions in the affirmative.

Motion was made by Leonard Colten seconded by Gerald Ball to accept the medical panel certificate finds and grant Gary Taylor accidental disability benefits pending PERAC approval. **Unanimously voted:**

Review Hull Supplementary Regulation for Benefits Pursuant to G.L. c. 32, §4(1)(h). The so-called "Military Buyback".

After a review of the Regulations and lengthy discussions for and opposed, the majority of the Board favored the regulations as written. Gerald Ball was opposed to having the person begin payments within the 180 days as well as the minimum bi-weekly payment amount. Maurice Murphy was also against the 180 days limit to begin payments.

Motion made by Leonard Colten seconded by Arthur Flavin to accept the Supplementary Regulations for Benefits Pursuant to G.L. c. 32, §4(1)(h) as written, pending PERAC approval.

So voted: Leonard Colten, Arthur Flavin and Marcia Bohinc yes. Gerald Ball and Maurice Murphy no.

Received letter from Michael Sacco dated 01/27/06 regarding termination of service with Kirkpatrick & Lockhart Nicholson Graham LLP. Mr. Sacco will be going into business for himself as the Law Offices of Michael Sacco.

Motion made by Leonard Colten seconded by Arthur Flavin to send a congratulation and well wish letter to Michael Sacco on his new endeavor.

Received Copy of Final Demand to the Hull Housing Authority sent by Michael Sacco.
