<u>Year-to-date trial balance and cash accounts reconciliation through December 2007 prior to year-end close. – January PRIM Board Update.</u> The Board reviewed the December 2007 pre-close trial balance and cash accounts. The Board once again was please that its investments exceeded its target rate of return for 2007. They reviewed the year-to-date PRIT statement in which the Board's net assets in the PRIT Core Fund increased by 2.6 million, almost a 12% increase. The total fees for 2007 were \$128,000.00. However, in January 2008, the fund lost \$1,054,000.00. The Board was positive that it would recover over the next 11 months.

<u>Pension Reserves Investment Management Board Executive Summary of Performance – Quarter Ending December 31, 2007 received by email from Michael Reardon.</u>

Received MACRS Fidelity Insurance Certificate for Policy Period 03/01/2008 to 03/01/2009. The Board acknowledge receipt of the Insurance Certificate and may peruse further insurance after its 01/01/2008 actuarial study, should its funding reached 50%.

The Board discussed whether it had the right to charge a member/retiree attorney fees in the event that said person failed to appear for a scheduled hearing without notification to the retirement office, in which the Board requires its attorney. Further discussed was the Board's right to withhold fees from retirement allowances. All persons would be notified in writing of said charge. The Board will contact its attorney for advice.

Motion made by Gerald Ball seconded by Leonard Colten, to advise, in writing, all persons seeking a hearing before the Board, which the Board determines it will require its attorney assistance, said person shall be notified in writing of the Board's obtaining of legal council, should they to fail to appear without sufficient notice, the Board is within its rights to charge them attorney fees.
