#### October 28, 2008 9:00 a.m. (Selectmen's Meeting Room)

The regular meeting of the Hull Contributory Retirement Board, duly posted to be held in the Selectmen's Meeting Room, Town Hall, Hull, MA on the above date was called to order at 9:00 a.m. Present were Marcia Bohinc, Chairperson, Members Leonard Colten, Maurice Murphy, Gerald Ball, Rocky Tenaglia, Retirement Administrator, Jennifer Miller and Town Manager, Phillip Lemnios.

Mr. Lemnios' request to address the Board was granted by the Chairman.

Mr. Lemnios advised the Board at this time the Town had formed a committee to conduct research options for trying to help cut the Town's budget for FY2010. One of the options consists of possibly joining the Group Insurance Commission. As required by statue, a retiree must be appointed by the Mass Retiree Association to represent the voice of the retirees of the Town of Hull in the Public Employee Committee (PEC). Mr. Lemnios requested that the Board appoint a member or that at least one of the Board members attend the insurance meeting to be held on November 4, 2008 to fill in as the retiree representative until one can be appointed by MACRS.

Rocky Tenaglia volunteered to fill in as the representative until a permanent representative can by appointed. The Board thanked Mr. Tenaglia for volunteering but had concern for a conflict of interest based on the fact that Mr. Tenaglia is not an actual retiree of the Town of Hull.

Marcia Bohinc will contact Ralph White of the Retiree Association regarding a retiree appointee to the insurance advisory committee. In the event no one is appointed prior to November 4, 2008, Marcia and Leonard Colten will attend as temporary appointees and update the appointee upon appointment.
