Service Credit

Richard Miller – Light Department – Request permission to purchase service credit for the period of June 29, 1977 through June 4, 1986 in which he had taken a refund from the Hull Retirement System. Cost to purchase nine (9) years of service \$30,627.62. (Verified by Payroll and Refund records)

Further, Mr. Miller worked for the Town of Hull from June 30, 1971 through September 8, 1971 in which he was not a member of the Hull Retirement System. – Current PERAC approved Board regulations state that a minimum of three (3) months is required for buy back purposes. The Board reserves the right to consider less time under a case-by-case circumstance. (Salary and dates verified by payroll records)

Motion made by Marcia Bohinc seconded by Leonard Colten to grant Richard Miller nine (9) years of creditable service for the period of June 29, 1977 through June 4, 1986 in which he had taken a refund from the Hull Retirement System, as well as two (2) months for the period of June 30, 1971 through September 8, 1971 in which he was not a member of the Hull Retirement System. Total credit to be granted upon proper payment to the Hull Retirement System nine (9) years and two (2) months.

- Accounts Payable Records from May 21, 1975 1976 (Jennifer has copies—Records indicate Mr. Miller was paid through the account payable warrant under different Power Companies, and not as an employee through payroll.)
- Hull Supplemental Regulations

Mr. Miller submitted three letter's from employees of the Town as affidavits on his behalf that he was employed at the Hull Light Plant.

The Board reviewed documents as provided by Mr. Miller as well as the PERAC approved supplemental regulations, which state "When purchasing non-member service, if payroll records cannot be obtained, then the applicant shall supply a W-2. An attempt should be made to acquire the Wage and Salary form from the Human Resource Department. The Retirement Administrator will assess the hourly wage, divided by the W-2 and determine if the hours worked qualified for purchasing service credit. If eligibility for membership cannot be determined, no credit will be granted".

Motion made by Marcia Bohinc Seconded by Gerald Ball based on the information provided to deny creditable service to Richard Miller for the period of May 21, 1975 through December 31, 1976. Should Mr. Miller provide the Board with the required documents the Board will reconsider at that time.
