Leonard Colten made a motion, seconded by Phil Lemnios to approve a 3% on 12,000 base Cost of Living Increase effective July 1, 2013. The cost is \$3,374.11 monthly and \$40,489.32 annually.

#### Service Purchases:

The Board has acknowledged the receipt of the approval of the supplemental regulations submitted to PERAC for approval regarding buyback regulations according to Chapter 176 of the Acts of 2011.

Phil Lemnios also requests that the administrator include acknowledgment from a member that if they wish to stop deductions at any time, they must go before the Board for approval. This is avoid members from stopping deductions at their own discretion with out the Board being made aware.

The Board Policy is to make members whole due to administrative error to the best of their ability and authority.

Phil Lemnios made a motion seconded by Brian Thompson to grant Joanne Marshall of the Hull School department permission to purchase service that had been refunded from the Massachusetts Water Resources Authority for service from September 20, 1993 through April 28, 1998. The cost to purchase service is \$8,088.66, for 4 years and 7 months, MWRA will accept liability. Ms. Marshall plans to enter into a payment agreement of payroll deductions in order to complete her purchase.

### **Unanimously Voted.**

Phil Lemnios made a motion seconded by Brian Thompson to grant Karen Thomas of the Hull School Departmentpermission to purchase service for the period of November 6, 1998 through September 19, 2004 which she worked for the Hull School department. Cost to purchase 5 years10 months service is \$5,499.28. Ms. Thomas plans to enter into a payment agreement of payroll deductions in order to complete her purchase.

Cost to purchase 1 year of service is \$4,024.26. Mr. Glavin plans to enter into a payment agreement of payroll deductions in order to complete hes purchase.

#### Retirement:

The Board was notified of receipt of Retirement Application for David McNair of the Hull Fire Department. Mr. McNair's date of retirement is January 25, 2013. No calculation is available at this time as final payroll deductions are waiting to be received.

## **Updates**:

The Board has received The Hull Contributory Retirement System Final Audit results for December 31, 2011 from MLBCPA, LLC. The Board reviewed the findings and are in process of making the appropriate corrections.

Marcia Bohinc also requests that the administrator add cash flow procedures and cash account maintenance balances to the Investment Policy provided by PRIT.

The Board would like to table the Retirement Administrator annual review for the February meeting. A contract has been drafted and handed out to the Board for review. Once the Board has had a chance to review that, they will be more prepared to discuss in February.
